Engaging Candidates at Events

In-Person & Virtual Events

"Town hall" meetings or candidate forums are a great time to share your concerns with candidates. Candidates regularly hold these sessions throughout the campaign cycle. They are often open to the public and include a question-and-answer session – giving you the opportunity to share the Think Babies message and ask the candidates where they stand on infant-toddler issues.

- ✓ Find an Event: Sign up for a candidate's email list, newsletters, and follow their social media accounts to get updates and check back to learn when they may be hosting public forums.
- ✓ Prepare: Once you have identified an event, prepare a brief statement or question using the worksheet below to help formulate your own questions to get you started. Always remember to pose open-ended questions.
- ✓ Follow up: Staff are a critical link in educating candidates and elevating issues. Don't forget to get contact information of key staff and follow up. Be sure to provide them with your contact information as well and remind them about your areas of expertise they may want to follow up with you down the road!



Questions for Candidates

Sample Opening Statement

- What will you do to expand access to quailty, affordable child care?
 - What is your position on paid leave to give families time to bond with their babies and
 - care for loved ones with serious ilnesses?
 - What is your position on expanding the Child Tax Credit and making it fully refundable to help provide safe housing, nutritious foods, adequate clothing and diapers?

Formulating a Question

For the most powerful impact, draft and practice your question before an event. Use this worksheet to create your own message-based question to use at an event.

Start with an Introduction
 Give the candidate a short introduction. This is as easy as stating your name and one other fact, such as your role with babies and toddlers.
 Hi, my name is ______ and I am the parent of ______ /I work with babies

2. Share a short story.

Sharing a short story helps the candidate connect the question back to real life situations and gives more power to the question. Write two or three sentences to tell a personal story related to the issue you would like to ask about.

3. Tie in the issue.

This is where you directly ask the candidate what they would do to help solve your problem. Do not offer them a solution, just ask a specific question about the issue and let them elaborate on it in their answer.

5. Put it all together to finalize your opening statement and question.

Vote for Babies!

Voters have countless opportunities to elect candidates who will make the needs of infants and toddlers their priority. Below are resources on how you can prepare to show up for young children and families at the ballot box:

1. Confirm Your Voter Registration

Check your voter registration status by visiting headcount.org and entering your information. If you are not already registered, you can register to vote there or update your existing registration as well.

2. Research the Candidates and Issues on Your Ballot

Visit <u>ballotready.org</u> or <u>ballotpedia.org</u> to:

- See every candidate and referendum that will be on your personal ballot, and
- Learn about candidates and their stances on the issues.
- 3. Make a Plan to Vote and Encourage Others to Do the Same
